



## PRIVACY POLICY

Sani-Marc Inc. and its affiliated entities (collectively referred to as the "**Company**") places great importance on your privacy and is committed to protecting your personal information.

When you provide us with personal information through our websites, we assume that you consent to the processing of your information in the manner described in this policy. Our websites include the following:

### 1. What is the scope of this policy?

This policy concerns you. It describes how we collect, use, communicate, and protect your personal information when you provide it to us on our websites. This policy also includes information on how you can exercise your rights, such as accessing or correcting your information.

Our websites may contain links to other websites or resources operated by third parties, such as when you click on links related to our social media accounts. These sites and resources are governed by the policies of those third parties, and the Company assumes no responsibility for them.

### 2. What is meant by "personal information"?



"**Personal information**" refers to any information which relates to a person and directly or indirectly allows that person to be identified. This includes a name, an online tracking identifier such as an IP address, or one or more specific characteristics related to their identity.

### 3. How do we collect your personal information?

We collect your personal information, in particular when you:

- browse our websites, for example through the use of cookies or other tracking tools;
- provide it to us on our websites, for example through our contact forms;
- create and log in to an account;
- apply for a job; and
- provide it to us when you purchase a product we offer or request a quote.

#### 4. What personal information do we collect and why?

We will only collect, use, and communicate your personal information in accordance with applicable privacy laws. For example, we will use your personal information solely for the purposes for which we have obtained your consent or for other purposes that may be required or authorized by law.

We use cookies as described below and in our banner.

Cookies are pieces of information that are transmitted and stored on your device to identify it or your account. They allow us, for example, to operate our websites, enhance their security, fix bugs, perform certain usage analyses, and tailor our content to better meet your needs and habits.

Specifically, our websites may use the following types of cookies:

Types of cookies	Explanation
<b>Necessary, Preference and Functional</b>	These cookies are necessary for the proper functioning of our websites. They allow us to ensure essential services and functionalities, including service continuity and security. Therefore, they cannot be disabled.
	Preference cookies allow us to remember information that changes the behaviour or appearance of our websites, such as your preferred language, the region you are in, and video and audio settings.
	Functional cookies enable certain functionalities such as sharing website content on social media platforms, collecting feedback, and other third-party features. These cookies do not collect or store any personal information about site visitors.
<b>LinkedIn Preference</b>	LinkedIn preference cookies are used to determine which LinkedIn data center is requested and for how long the LinkedIn service can use the cookie information.
<b>Analytics and Statistics</b>	These cookies generate anonymous data on the number of visits and how visitors use our websites. This data helps us improve our services and the visitor experience on our websites.
<b>Advertising</b>	These cookies allow us and our partners to recommend more relevant products and services to you and display advertisements, including on other sites, that take into account your tastes and browsing habits. This is what is referred to as interest-based advertising (targeted advertising). Please note that if they remain disabled, the number of advertisements will not decrease, but they will be less relevant to you.
<b>Other</b>	Other uncategorized cookies are other analytics and statistics cookies used by our analytics platforms, among other things, to recognize our visitors.

## 5. How do we obtain your consent?

The way we obtain your consent (i.e., how we do so) depends on the circumstances.

- We may ask for your explicit consent. However, consent can also be implicit, meaning it is inferred from your inaction or the circumstances.

- If we wish to use your personal information for a purpose that was not disclosed to you at the time of collection or that is not permitted by law, we will seek your consent again.

## 6. To whom do we communicate your personal information?

We may communicate your personal information to other organizations, such as our service providers, for the purposes identified in the section **What personal information do we collect and why?**

In such cases, we strive to protect the personal information communicated through written agreements and commitments, requiring these third parties to adopt good privacy practices and measures consistent with our expectations and applicable laws regarding your personal information.

<b>Courts, law enforcement, and other public authorities</b>	<p>We may share your personal information when required or permitted by law, regulation, court order, subpoena, valid request, or search warrant, or in response to an investigation or any other legitimate request.</p>

## 7. How long do we keep your personal information?



We will keep your personal information for as long as necessary to fulfill the purposes outlined in this policy, unless the law or an exceptional situation requires us to keep it longer. This could occur, for example, in the event of a legal dispute.

## 8. Where do we keep your personal information?



We currently keep the personal information collected on our websites in Quebec, Canada. However, your personal information may be held and used in any country where our service providers are located. As a result, we may transfer personal information to countries other than your country or province of residence, where other governments may have access to it under applicable laws.

If we communicate personal information outside of Quebec, we will ensure that your information is protected at a level equivalent to that in Quebec, for example, through contractual measures.

## 9. How do we protect your personal information?

### Security Measures

We implement reasonable procedures and security measures to protect your personal information, whether stored on our servers or with one of our service providers.

For example, we limit access to your personal information. Only staff members who need to process your personal information as part of their duties have access to it.



We have defined the roles and responsibilities of our staff throughout the life cycle of your personal information, from its collection to its destruction.

We have put in place robust security measures to protect your personal information from loss, theft, and any unauthorized access, use, or communication. These measures include:

- Physical measures, such as locked premises;
- Technological measures, such as firewalls;
- Organizational measures, such as the adoption of an incident response plan.

## 10. What rights do you have regarding your personal information?

Depending on your place of residence, you have several rights concerning your personal information, including:



### Right of access, rectification, and deletion

You can request access to the personal information we hold about you and obtain a copy.

If any personal information concerning you is inaccurate, incomplete, or ambiguous, or if its collection, communication, or keeping is not authorized by law, you can request that it be rectified.

If any information is outdated or no longer necessary, or if provided by law, you can request that we delete it.



### Right to withdraw consent

You can request to withdraw your consent to our use or communication of your personal information.

In most cases, withdrawing your consent means we will no longer be able to fulfill your request or provide the products and services you requested. Otherwise, we will inform you of the consequences of your request in our response.

We may ask you to provide proof of identity before responding to your request. This identification information will be used only for this purpose.
